2. I hereby accept the rules and procedures as outlined in this application form including the terms and conditions set out in the **2019** Seasonal Campsite Use Agreement.

3. I am an EID water user who owns irrigation acres ("first water rights") or who has been granted a terminable agreement for irrigation purposes ("second water rights") and the legal description of my land on which such water rights are located is:

4. CVRS expects that the seasonal campsites will be available for occupancy on a seasonal basis for the **2019** camping season commencing on **May 1, 2019** and ending not later than **September 30, 2019**.
5. Subject to the outcome of the draw and campsite selection processes, CVRS will enter into a maximum of one Seasonal Campsite Use Agreement per applicant ([single person or couple, not a company or other organization](#)).

6. My application, if deemed eligible in the sole discretion of CVRS, will be entered into a draw to be conducted by CVRS. If deemed ineligible, CVRS's only obligation to me is to return my **\$500** application fee.
7. The deadline for receipt of an application at the Bassano Post Office is **4:30 pm on, Friday March 8, 2019.** Any application received after this date and time will not be included in the seasonal campsite draw. In order to be eligible for the draw, please mail completed applications to CVRS, Box 567, Bassano, AB T0J 0B0.
8. On **Wednesday April 3, 2019 at 7:00 p.m.** in the Bassano Community Hall located at 610 2nd Avenue Bassano, AB, CVRS will hold a campsite selection meeting where CVRS will sequentially draw names from the eligible applications up to the number of campsites CVRS designates as being available for occupancy on a seasonal basis (the "seasonal campsites").
9. I understand that CVRS intends to grant a Seasonal Campsite use Agreement to a minimum of four (7) EID water users and that CVRS's seasonal campsite draw process will be designed to meet these criteria.
10. If I am personally unable to attend the campsite selection meeting, I may, in writing, authorize another person to attend the meeting ("my authorized representative") and to act in my behalf. I understand that such person must deliver my written authorization to CVRS **before 7:00 p.m. on Wednesday April 3, 2019** in order to be allowed to act in my behalf.
11. I agree to attend the campsite selection meeting either personally or by authorized representative. If I am not personally in attendance or my authorized representative is not in attendance at the commencement of the campsite selection meeting (Bassano Community Hall) on **Wednesday April 3, 2019** I will automatically forfeit my opportunity to participate in the seasonal campsite draw and I will also forfeit my **\$500** application fee to CVRS.
12. If my name is drawn and I am present either personally or by my authorized representative, I will be given a time-limited opportunity (not to exceed 3 minutes) to choose from the seasonal campsites remaining available at the time of my turn.
13. I understand that if I am given an opportunity to choose a campsite and fail to do so within the limited time allowed, I will have lost my opportunity to choose a campsite and my **\$500** will be forfeited to CVRS.
14. If I fail to execute a Seasonal Campsite Use Agreement and to pay the balance of the seasonal campsite fee on **Wednesday April 3, 2019,** I will forfeit my opportunity to occupy that campsite and my **\$500** application fee will be forfeited to CVRS.

16. If my name is not drawn or if there are no seasonal campsites remaining available when my name is drawn, CVRS's only obligation to me is to return my **\$500** application fee.
17. "I am willing to enter into a Seasonal Campsite Use Agreement for only the type of season that I have marked below. If my name is not drawn or if my name is drawn and there are no seasonal campsites remaining available of the type marked, my name will automatically be withdrawn from the seasonal campsite draw and CVRS' only obligation to me is to return my \$500.00 application fee."
